#### **SCHEDULE 13G/A**

This Amendment No. 4 to Schedule 13G (the "Amendment") is an amendment to the initial statement on Schedule 13G relating to shares of common stock, par value \$0.01 per share (the "Common Stock") of Gulfport Energy Corporation, a Delaware corporation (the "Issuer"), filed with the Securities and Exchange Commission (the "SEC") on March 10, 2005, (the "Schedule 13G").

This Amendment is being filed on behalf of Southpoint Capital Advisors LLC, a Delaware limited liability company ("Southpoint GP, LLC"), Southpoint GP, LLC, a Delaware limited liability company ("Southpoint GP LLC"), Southpoint Capital Advisors LP, a Delaware limited partnership ("Southpoint Advisors"), Southpoint GP, LP, a Delaware limited partnership ("Southpoint GP"), Robert W. Butts and John S. Clark II. Southpoint CA LLC is the general partner of Southpoint Advisors. Southpoint GP LLC is the general partner of Southpoint GP. Southpoint GP is the general partner of Southpoint Fund LP, a Delaware limited partnership (the "Fund"), Southpoint Qualified Fund LP, a Delaware limited partnership (the "Qualified Fund"), and Southpoint Master Fund, LP, a Cayman Islands exempted limited partnership (the "Master Fund"). Southpoint Offshore Fund, Ltd., a Cayman Island exempted company (the "Offshore Fund"), is also a general partner of the Master Fund. This Amendment relates to shares of Common Stock of the Issuer purchased by the Fund, the Qualified Fund and the Master Fund.

#### Item 4 Ownership.

Item 4 is hereby amended and restated as follows:

- (a) Southpoint CA LLC, Southpoint GP LLC, Southpoint GP, Southpoint Advisors, Robert W. Butts and John S. Clark II may be deemed the beneficial owners of 4,183,621 shares of Common Stock.
- (b) As of December 31, 2007, Southpoint CA LLC, Southpoint GP LLC, Southpoint GP, Southpoint Advisors, Robert W. Butts and John S. Clark II may be deemed the beneficial owners of 9.86% of the outstanding shares of Common Stock. This percentage was determined by dividing 4,183,621 by 42,447,755 which is the total number of shares of Common Stock outstanding listed on the Issuer's most recent form 10Q for the quarterly period ended September 30, 2007, plus the number of Common Shares issued in connection with the Issuer's recent public offering of Common Shares, as reported on the Issuer's most recent form 8-K filed on December 7, 2007.
- (c) Southpoint CA LLC, Southpoint GP LLC, Southpoint GP, Southpoint Advisors, Robert W. Butts and John S. Clark II have the sole power to vote and dispose of the 4,183,621 shares of Common Stock beneficially owned.

#### Item 10 Certification.
